1. The Malawi Communications Regulatory Authority (MACRA) has budgeted funds to be used for the Supply, Delivery, Installation and Testing of Internal Auditing Software for the Authority.
2. **The Chairperson, Internal Procurement Committee (IPC)**, now invites sealed bids from eligible bidders for supply and delivery Installation and Testing of Internal Auditing Software for the Authority.
3. Bidding shall be administered in accordance with the National Competitive Bidding (NCB) procedures as specified in the Malawi Public Procurement Act, 2003 and its subsidiary legislation.
4. Interested eligible bidders may obtain further information and inspect bidding documents from MACRA's Procurement Department at the address given in paragraph 7(i) below from **08:00 – 12:00 hrs, 13:00 to 16:00** local time (Monday to Friday) except national public holidays

5. A complete set of Bidding Documents in English language may be obtained by interested bidders at 7(ii) upon payment of a non-refundable fee of **MK5, 000.00**. The method of payment will be cash or Bank Certified cheque. The documents may be obtained in person by the prospective bidders.
6. Sealed bids must be submitted to the address at 7(iii) below at or before **15:00 hours on Friday, 19th January, 2018**. Late bids shall be rejected and returned to the bidder unopened.
